Focus of SC meetings

- Review of the audited accounts of the previous years
- Review of the financial situation of the current year and forecast of the income and expenditure until the year's end, and adoption of the budget for the following year
- Review of the work of the Secretariat
- Review of the reports on the implementation of the work programmes of the Scientific and Technical Review Panel (STRP) and the CEPA Oversight Panel and recommendations for their future work
- Consideration of the projects submitted under the Ramsar Small Grants Fund for Wetland Conservation and Wise Use (SGF) and approval of projects to be funded
- Review of the financial and implementation status of other projects undertaken by the Secretariat

SC 33 OUTCOMES

- Uganda (Represented by Paul Mafabi) elected as SC Chair and Bahamas (represented by John Bowleg) as Vice Chair
- USA elected as Chair of Sub-group on Finance. Members – Benin (Africa), China (Asia), Czech Republic (Europe) Ecuador (Neotropics) USA (North America) and Samoa (Oceania)
- Agreed on Transition meeting to be held immediately prior to SC34

SC 34 OUTCOMES

- Four sub-committees established
 - Management Working Group
 - COP 10
 - CEPA Oversight Panel
 - STRP Oversight Panel
- Endorsed the Joint Work Plan with CBD
- Agreed process for the election of New Secretary General
- Elected Mr. Anada Tiega as SG in May 2007

- Agreed financial allocations for regional initiatives for 2007
- Proposed formal establishment of a transition committee (DR)
- Established procedure for resolving grievances at the Secretariat
- Agreed national report format and process
