# Provisional working programme

The purpose of the 26th meeting of the Scientific and Technical Review Panel (STRP26) is to take stock of progress made and further advance the high priority tasks under the <u>STRP workplan for the 2023-2025</u> triennium. The five Thematic Work Areas (TWAs) in <u>Annex 2 of Resolution XIV.14</u> encompass 18 tasks that are aligned with the <u>Fourth Strategic Plan of the Convention</u> (2016-2024). STRP26 will also address the development of targets and indicators under the forthcoming 5th Strategic Plan of the Convention on Wetlands and discuss emerging issues.
