1. Regional collaboration on wetlands is not funded from national budgets. Only development partners may finance RRI-CA collaboration and activities.

2. Staff of national designated authorities are not always capable to prepare the dossiers and promote the wetland to Ramsar designation. Regular capacity building is needed. Inclusion of relevant course to the Academies for enhancing the potential of civil servants.

3. Economic approach to protect the ecosystems of wetlands is the only way to have resources for needed activities on local level. CAREC started explanation of this approach and, hopefully, will have a relevant project with GIZ.
