



**RAMSAR CENTRE FOR EASTERN AFRICA (RAMCEA)  
2016 Report**

**1. Introduction**

The idea to establish a regional centre was first conceived in 2005 as a legacy for Uganda's hosting of the 9th Conference of the Contracting Parties to the Ramsar Convention on Wetlands (Ramsar COP9). RAMCEA is a regional initiative established under Article 5 of the Ramsar Convention on Wetlands and endorsed at the 10th Conference of the Contracting Parties held in Changwon Republic of Korea in 2008. The Centre started its operations in 2009 and is hosted by the Wetlands Management Department in the Ministry of Water and Environment of the Republic of Uganda.

The goal of RAMCEA is to “support the East African Contracting Parties, Non-Contracting Parties and other stakeholders to improve their capacity to implement the Ramsar Convention in the respective countries and institutions”. This includes among others, sharing regionally the policies, legislation, procedures, systems, tools, techniques, Best Practices, lessons learnt and experiences in wetland management.

The Vision of the RAMCEA Strategic Framework is “Eastern Africa wetlands understood, valued and sustainably managed”. This is inspired by the mission of RAMCEA which is to “Strengthen wetland management through institutional coordination, capacity building and experience sharing”.

The overall goal of RAMCEA is to have a “well-coordinated, strengthened and networked institutions for wise use and conservation of wetlands in the region”.

The Centre initially covers the five countries of the East African Community namely: Republic of Kenya, United Republic of Tanzania, Republic of Rwanda, Republic of Burundi, and Republic of Uganda, but will seek to establish links with other interested relevant Contracting Parties and non-Contracting Parties' in the region such as Djibouti, South Sudan and Ethiopia.

RAMCEA will also have links to other African regional and sub-regional wetland initiatives such as the Lake Victoria Basin Commission, Nile Basin Initiative, The Centre for African Wetlands of Accra Ghana, Kenya Wildlife Service Training Institute Naivasha and the network for wetland professionals based in UNESCO-IHE (Delft).

## 2. 2016 activities

### 3. On-going activities

RAMCEA has over the last year engaged in a number of collaborations geared at effort to mobilise resources to support the implementation of the RAMCEA strategic framework and also creating networks for implementation of the various outputs. Joint proposal were developed between European Space Agency, Danish Hydraulic Institute and Geoville to harness on the strengths of the various players.

RAMCEA is currently implementing several projects that include “Sustainable use of critical wetlands in the Lake Victoria Basin Project” which is collaboration with Birdlife International; GlobWetland Africa, a large Earth Observation application project funded by the European Space Agency (ESA) in partnership with the African Team of the Ramsar Convention on wetlands. GlobWetland Africa project is initiated to facilitate the exploitation of satellite

observations for the conservation, wise-use and effective management of wetlands in Africa and to provide African stakeholders with the necessary Earth Observation (EO) methods and tools to better fulfill their commitments and obligations towards the Ramsar Convention on Wetlands.

However, there have been challenges with implementation of several planned activities due to limited funding. Much as Government of Uganda contributed substantially to most of the implemented activities, the funding was inadequate.

Therefore, a lot of effort will be placed in resource mobilization, lobbying of the various partner states to support implementation of key outputs and creating of networks with other local, regional and international institutions that can finance and support implementation.
