The IBRRI Strategic Plan was endorsed by the five member countries in February and has served as a framework for the implementation of wetland conservation in the IBRRI region. In May, as a component of the Strategic Plan, IBRRI and RRC-EA hosted a Regional Wetlands Policy Dialogue, bringing together representatives from governments in the IBRRI region to analyse the strengths, weaknesses, opportunities and threats regarding regional wetlands policy. During the dialogue session, critical gaps were identified, particularly the regional underrepresentation of wetlands in climate change mitigation and adaptation policy. Particular attention was given to SDG 13 on Climate Action as well as to the National Determined Contributions (NDCs) developed as part of the Paris Agreement.

The results of the Climate Change Vulnerability Assessments for the ten wetlands in the IBRRI region have demonstrated the various threats to wetland ecosystems, species and local livelihoods. They provide national governments with concrete examples of climate change impacts, and the results are informing the development of climate change adaptation plans at the sites.

Intensive ten-day national wetlands trainings with wetlands rangers and local and provincial governments helped to strengthen wetlands management in the IBRRI region. The trainings addressed wetland ecology, climate change impacts, and tools such as RAWES, R-METT, and Vulnerability Assessments, increasing capacity of those directly responsible for Ramsar sites in the region. Citizen journalism reporting by community members is also helping to highlight wetland ecosystem benefits from a new point of view, and national broadcasts are serving to increase awareness of wetlands throughout the countries.

The Ministry of Environment, Cambodia volunteered to host the IBRRI Steering Committee meeting and technical workshop for 2019, however due to scheduling conflicts, they were ultimately unable to host within the calendar year. The meeting has been postponed to February 2020, in Siem Reap.

IBRRI is currently prioritising the co-funding provided through the BMU-IKI funded Mekong WET: Building Resilience of Wetlands in the Lower Mekong Region through a Ramsar Regional Initiative, which ends in 2020 and has significant budget to support IBRRI activities, as the development of a Ramsar Regional Initiative was a key component of the project. The IBRRI Secretariat is currently exploring additional funding sources to provide financial support to IBRRI from 2021 onwards, however, has not yet found an appropriate donor. The decision was made to prioritise BMU-IKI funding while it is available, and reserve the Ramsar funding to assist in supporting IBRRI once the Mekong WET project has ended.

The remaining funds are committed to support the Ministry of Environment Cambodia in hosting the IBRRI Steering Committee and Annual Meeting in Siem Reap in February 2020, and the transboundary trainings between IBRRI countries.
