4. Are the strategic and operational targets of your initiatives fully aligned with the Convention's Strategic Plan, please explain how this is done:

The overall aim of Ramsar Regional Initiative Black Sea Coastal Wetlands – BlackSeaWet is to catalyze the conservation and sustainable development of Black Sea coastal wetlands. Wetland wise use and conservation has been initiated in the region for many years through various unrelated regional and national activities. The BlackSeaWet Regional Initiative is planned to stimulate and coordinate cooperation around coastal wetlands issues in the region, acting as a means to address regional issues, share knowledge and expertise to address shared issues amongst different countries and stakeholders in the region and stimulate the development of capacity to address them. The issues require a multi-stakeholder approach that engages with government, civil society and increasingly the private sector. The Regional Initiative is planned to undertake to bring these parties together.

The BlackSeaWet Initiative will strongly promote the goals of the Ramsar Strategic Plan 2009-15.

Of the five main goals, the Initiative is focused to contribute to the realization of 1-4 (the fifth not being relevant in the region as all countries are already Contracting Parties):

Wise use (Goal 1) - Promotion of the wise use of coastal wetlands is a key focus of BlackSeaWet Initiative;

Wetlands of International Importance (Goal 2) - Many of the major Black Sea coastal wetland are listed as Ramsar sites);

International cooperation (Goal 3) - International cooperation is a crucial part of BlackSeaWet Initiative;

Institutional capacity and effectiveness (Goal 4) - BlackSeaWet Initiative is planned to contribute on building the regional capacity to implement the Convention focusing on enhanced CEPA activities to catalyze implementation of wise use.

Coordination between Regional Initiatives and the Secretariat (current points 5-10 of the Op. Guid.)

The contacts with the Convention Secretariat is very good, acting close with the **Management Body** and the **Coordination Unit** with the financial support and participation on the BlackSeaWet Initiative Meetings;

Having in view the existing situation in the region (countries member EU and countries non-member EU), the lack of experience of partners on promoting the management of coastal wetlands, communication, regional cooperation it is necessary the continuation of the financial support for the next triennium, in view to support the participation of the partners on meetings, workshops, working groups to improve the development of the cooperation between the partners.

BSW Regional Initiative has been established the **Management Body** (formed from two representatives from each country – partner: the representative of the ministry - national authority for environmental protection and the representative of a representative NGO), the **National Working Group** (formed, on voluntary basis, from representatives of NGOs and experts in coastal wetlands management). The Management Body is assisted by an Implementation Unit based in Danube Delta Biosphere Reserve Authority in Romania.
The Management Body is planned to have periodic (but not less than 1 per year) meetings.

Each meeting of the Management Body is recorded in a Meeting Minute, publicly available on the request and are posted on BSW Initiative website.
