Draft Agenda and organization of work

- 1. A full Annotated Agenda will be prepared in consultation with the STRP Chair and circulated prior to the 11th meeting of the Panel.

In doing that, the STRP should give consideration to geographical and gender balance and to the language abilities of the proposed experts; and
 - iv) identify key additional strategic issues for consideration by the STRP in relation to: a) the current tools and guidance available to Parties; and b) any new and emerging issues for the Convention; and establish a Working Group to progress these for reporting to the next COP.
- 5. In undertaking tasks ii) and iii) the Panel will be assisted by advice from the STRP Support Service (see document STRP11-7).
