





Celebration of WORLD WETLANDS DAY 2011 and 40th Anniversary of the Ramsar Convention on Wetlands

These events were celebrated with much fervor in the Republic of Mauritius as it also coincided with the 10th anniversary of Mauritius acceding to the Convention and Rivulet Terre Rouge Estuary Bird Sanctuary (RTREBS) nominated as our first Ramsar Site.

The National Parks and Conservation Service (NPCS) of the Ministry of Agro Industry and Food Security being the National Focal Point for Ramsar organized several events on the 2nd February 2011.

Various activities were carried out on that day:

A half date workshop on the importance of wetlands was held at the Visitors Centre of RTREBS.

On that occasion, being given that the theme for this year World Wetlands Day and the United Nation laid emphasis on importance of Forests ecosystem, NPCS organized a special tree planting ceremony at the Ramsar site. A critically endangered endemic plant was planted by the Honourable Minister.



A rare endemic plant namely *Psiadia cataractae* planted by the Hon. Minister. This species is critically endangered as per IUCN criteria as less 10 individual exist in the wild.

A poster on migratory birds was also launched by the Hon. Minister. More 600 has been distributed to all educational institutions of Mauritius (Primary, Secondary and Tertiary Institutions).



The Government of Mauritius has shown an increase in commitment towards wetlands protection. Further activities have been planned to be organized throughout the year namely:-

- 1. Exhibitions, talks and sensitization campaigns on the importance of wetlands to be organized in different schools
- 2. Opening of the RTREBS to the public during weekends and public holidays
- 3. Opening of a Craft market and a bird hide at RTREBS under a joint project of Force Vive de Roche Bois, a local NGO and NPCS, funded by the UNDP/GEF SGP and Shell Mauritius.
- 4. Declaration of Pte d'Esny as a wetland of International Importance (awaiting a favourable reply from the Convention)
