

CONTRACTING PARTIES CONTRIBUTIONS FOR 2016

The following information gives the Contracting Parties a detailed view of the changes from 2015 to 2016.

Notes:

1. 2016 contribution calculation is based on UN Scale of Assessment percentages for 2016 (as published on 28 December 2015, Document number ST/ADM/SER.B/932).
2. The UN Scale of Assessments is adjusted, on a pro rata basis to reflect the actual membership of the Convention at 1 January 2016, to create the "Ramsar Scale of Assessment".
3. The calculations are based on the 2016 budget of CHF 4,844,000 approved by Contracting Parties at COP12 (June 2015).
4. As per Resolution X.2, paragraph 15, the minimum contribution is CHF 1,000.
5. The calculation is based on Contracting Party membership as of 1 January 2016.
